Harvest Moon General Information

DEFINITIONS/ELIGIBILITY:

JR/YR – Riders are eligible to compete in these classes until the end of the calendar year in which they reach the age of 21. FEI JR Tests - only riders ages 14-18. FEI YR Tests - only riders ages 16-21. FEI Pony Tests - only riders ages 12-16. FEI Children Tests - only riders ages 12-14. Include birth date on entry.

AA – Adult Amateur – Individuals possessing current amateur certification are only eligible as AA from the beginning of the calendar year in which they turn 22. Only active USEF members may obtain amateur status. **PE** – Para Equestrian – Riders must have a current USEF Dispensation Certificate which indicates their classification status to be eligible. All tests in standard arena.

CBLM – Colonel Bengt Ljungquist Memorial Championship qualifying class for 2023. Riders must be member of a participating GMO at the time of the show to be eligible.

USDF Q – Qualifying class for 2024 GAIG/USDF Regional Championships. Declare qualifying ride on entry form and pay additional \$15 qualifying fee prior to start of class.

AWARDS:

- Trophy & ribbons to sixth place in all classes with 3 or more per division. Ribbon for classes with only 1 entry.
- Stock Horse High Score: (QH, Paint, Appaloosa) special prize sponsored by EZIUM.

USEF Rule DR129.9: Except for USEF/USDF Championship classes and for FEI Pony Riders, FEI Junior and FEI Young Rider Freestyles, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% for Training through Fourth levels and 60% for FEI levels in the highest test of the declared freestyle level or any test of a higher level at a Federation /USDF Licensed Dressage Competition or FEI recognized Dressage Competition or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. To enter an FEI Para Dressage Freestyle class, © USEF 2022 DR - 59 a horse/rider combination must have received a minimum score of 60% in any FEI Para Dressage test (Introductory, Novice, Team, Individual) at the rider's classified Grade. This score may be earned at a USEF/USDF licensed Dressage Competition or FEI recognized Dressage Competition or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility, or copy of the USDF score verification, must be submitted with the entry for a freestyle class. All FEI Pony Rider Tests are equivalent to Second Level; all FEI Junior Tests are equivalent to Third Level; all FEI Young Rider Tests are equivalent to PSG; and the USEF Brentina Cup (Young Adult) Test and FEI Young Rider Grand Prix 16-25 Tests are equivalent to Intermediate II. For purposes of freestyle qualification, all are considered equivalent to the highest test of that level and may be used to enter a freestyle at that level or a level below. Young Horse and FEI Children Tests cannot be used for freestyle qualification at any level.

STABLING:

Permanent 12 X 12 stalls with doors and rubber mats, 10' overhang and some permanent hardware. No shavings are included, you are allowed to bring your own. Shavings should be ordered in advance (\$10.00). Please order your shavings with entry. There will be a limited quantity of extra shavings available at the show and it will be \$11.00 per bag.

DO NOT put <u>any</u> items in empty stalls. Doing so will result in you being billed for a tack stall.

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of March Magic Dressage. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

USEF SafeSport Reminder

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

Entry Information:

Entry Information Requirements: Competitors are responsible to provide valid membership numbers on the entry form for all horse, owner, rider, and trainer names listed on the entry form. USEF and USDF registration is verified electronically if valid membership numbers are provided on the entry form. Safe Sport Training must have been completed for USEF membership to be valid. You may be asked to provide copies of your membership documents if your memberships cannot be verified for any reason.

No horse will be permitted on the grounds without a valid health certificate or proof of vaccinations (Equine Influenza Virus & Equine Herpes Virus (Rhinopneumonitis) within 6 months prior to arriving. Rule GR845

SAFE SPORT TRAINING is required for all **riders**, **owners and trainers** within 30 days of membership. If Safe Sport Training has not been completed within 30 days of membership, entries will not be accepted until proof of completion is provided. If membership is renewed during show, Safe Sport Training must be completed within 30 days or results will be nullified.

Entries must be received by Midnight of the closing date. Any entry still requiring a signature, payment, or copies of proof of valid membership (including Safe Sport Training) by September 13th will be considered incomplete and will incur a late paperwork penalty fee of \$10. No refunds after closing date, for any reason.

- All fees must be paid in US funds. Fees must be paid with entry. Entries not accompanied by fees will be considered late and not entered until fees are received including any late or post entry fees. Returned checks will nullify entry until debt is satisfied. Returned check fee is \$40.
- Entries submitted after closing date will be considered late, see below.
- Numbers will not be given out until entries have been submitted to the show AND owners, riders and coaches
 or trainers have signed all entry blanks.
- Only one horse-rider combination per entry form.
- Management reserves the right to cut off entries prior to closing date if show is full.

Late Entries: Late entries may be accepted after the closing date if space is available, upon payment of an additional late entry fee of \$40. All late entries must enter and pay online – email for late entry permission.

Policy for Class Changes and Filling Scratches in classes: Must be eligible for class. Must have previously entered in competition as a competing or non-competing horse.

Pony Measurement: Pony measurement will be done by appointment. Please sign up in advance. A fee of up to \$100 will be charged by the veterinarian.

Para-Equestrian competitors and their horses are no longer exempt from USDF memberships. Para-Equestrian competitors will now be required to have a USDF participating or group membership or a Non Member fee will apply. All horses will need a life or HID USDF membership.

Day Trailer parking: Pay per day parking fee and park in areas designated by show management.

Musical Freestyles: Music must be submitted electronically with entry. Sound check will be on Friday evening or early Saturday morning, check with show office. Competitor is responsible for attending sound check to make sure music works properly.

Numbers must be worn at all times when a horse is being walked, exercised or ridden.

Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/or stall fee before or during the show for cause; all without being liable for damage or compensation. Show management reserves the right to make any changes deemed necessary for the safe and efficient conduct of this competition.

Weather/Acts of God/Accidents or Emergency Policy: Management reserves the right to cancel any classes due to hazardous weather, Acts of God, Accidents or Emergencies. Every effort will be made to reschedule with priority given to USEF Program classes. No refunds for cancellations due to hazardous weather, Acts of God, Accidents or Emergencies.

No Shows: All "No Shows" that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.

"Attention Competitors as of January 1, 2019, if you are a USEF competing member 18 years of age or older you are required to take the core Safe Sport training within 30 days of activating our membership. Take the Safe Sport Training at USEF.org by logging into your member dashboard."

Entry Information (cont'd):

Membership/Registration Requirements for GAIG/USDF Qualifying Classes: Riders must be current USDF Participating members & USEF members (Junior, Senior or Life) in good standing and this included Safe Sport Training. Horses must be USDF Lifetime Registered and USEF Annual or Lifetime Recorded. Horses with only an HID are not eligible. Owners must be current USDF Participating or Business members & USEF members (Junior, Senior or Life) in good standing. For current Great American/USDF Championship requirements, go to www.usdf.org/competitions/competitionschampionships/regionals/index.asp.

Great American/USDF Qualifying Classes: Please indicate that the class is to count for qualifying by placing a Q after the class number. Class fee plus additional \$15 fee must be paid prior to start of the class. Qualifying will not require a separate ride. See USDF 2024 GAIG/USDF Regional Championship Program Rules pages for membership requirements.

Show Schedule and Ride Time Conflicts: It is the responsibility of the rider to inform the management of any time conflicts as soon as possible after receiving the schedule.

Additional Stabling Information:

- **Stable Group:** Please list stable group on entry form and use only **one group name** for each stable group to ensure that your group will be stabled together.
- Stalls will be ready to use by 11:00 am on Thursday
- Any stall changes MUST be cleared with show office.
- Trailer-ins must pay daily grounds fee and park in designated areas.
- No exhibitor may withdraw horses from a licensed show after it has commenced, or remove them from the showgrounds without permission of the show secretary or show manager.
- · Lungeing in designated areas only.

Pets: Dogs **must be on leashes or otherwise restrained AT ALL TIMES** while on show grounds, including in the stable area. Dog owners are soley responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Dogs should not be kenneled overnight in the stable area. Dog owners failing to comply will be issued a Yellow warning card and non-compliance may result in further USEF penalties.

ATTENTION COMPETITORS

Each competitor is responsible for supplying management with correct applicable numbers (USDF and USEF) for horse, owner, rider, and trainer, before the day(s) of the competition.

The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

ATTENTION COMPETITORS –HEADGEAR RULE FOR DRESSAGE

Protective headgear –DR120.6 (GR801.6) From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, mounted participants in exhibition classes and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such head-gear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted. Unless jackets are waived, while in the competition ring, exhibitors wearing protective headgear must wear a short, dark jacket, dark tail coat (only permitted for tests above Fourth Level), or Armed Services or police uniform (if eligible), dark hat covers (where applicable) and must other-wise conform to DR120 (see GR801).

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

MODIFIED DRESS CODE FOR RIDERS IN OPPORTUNITY CLASSES

Riders in classes and tests at all levels in Level 1 Competitions, and riders in Opportunity classes in Level 2 and Level 3 Competitions, may compete wearing breeches and shirts of any color as permitted in DR120.8. Jackets or vests of any type are allowed but not required and neckwear may be worn only if the rider chooses to compete in a riding jacket. Boots and protective headgear are required as specified in DR120.1-6. USEF DR120.5. ACCORDINGY, JACKETS ARE NOT REQUIRED FOR ANY RIDERS IN THE OPPORTUNITY CLASSES AT THIS COMPETITION.

Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8th Place and gift certificates awarded to top three riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.
- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult
 amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

The USDF Regional Adult Amateur Equitation Program rules and information can be found on the USDF website.

USEF MEMBERSHIP STATEMENT

GR901.9 Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

USEF MOTORIZED VEHICLE STATEMENT:

GR1301.7 & GR 1301.8 Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to Segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Fly hoods permitted for all classes (indoor and outdoor)

Fly hoods (ear covers) are permitted for all classes in order to protect horses from insects. The fly hood should be discreet in color and design and should not cover the horse's eyes. After completion of the test, the rider or his/her representative is responsible for removing the fly hood to present to the designated ring steward for inspection to ensure that nothing prohibited has been added (for example, ear plugs). <u>USDF Membership Benefits:</u> USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at www.usdf.org.

This competition is recognized by USDF for 2023

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
 sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
 Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
 exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
 academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
 identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan*/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program. **Business Membership (BM)**: A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan*/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

I acknowledge, understand, and agree, in consideration of my participation in equine activities at the Carolina Horse Park ("CHP Facilities") including, but not limited to, shows, exhibitions, schooling days, community events and competitions ("CHP Events"), as a volunteer, participant, owner, lessee, coach, trainer, employee, or contractor, and that my participation in equine activities and CHP Events are voluntary and at my own risk. I understand that there are inherent risks of loss and accident associated with participation — including bodily and personal injuries, death, and property damage —to participants, bystanders, and horses including but not limited to (a) serious bodily injury; (b) sickness and disease (including communicable diseases); (c) trauma, pain & suffering, permanent disability, paralysis and death; (d) loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; (e) exposure to extreme conditions and circumstances; (f) accidents involving other participants, event staff, volunteers or spectators; (g) contact or collision with other participants and horses, natural or manmade objects; (h) adverse weather conditions; (i) facilities issues and premises conditions; (j) failure of protective equipment (including helmets); (k) inadequate safety measures; (l) participants of varying skill levels; (m) situations beyond the immediate control of the CHP Facilities organizers and competition management; (n) and other undefined, not readily foreseeable and presently unknown risks and dangers; and, further, that:

There are, at any and all times, likely to be participants in equine activities on the CHP Facilities, and, despite the risks set forth above, I knowingly and voluntarily choose to use CHP Facilities and assume any and all risks related to the activity to the maximum extent permitted by law. Should medical treatment be required, I or my own medical insurance company shall pay for all such incurred expenses.

I hereby release, waive, and discharge Carolina Horse Park Foundation and its officers, directors, employees (including contract employees), and volunteers (collectively, "CHP Parties"), to the maximum extent permitted by law, from any and all claims, demands, actions, and rights of action of whatever kind or nature, in law or in equity, known or unknown, arising from or related to any bodily or personal injuries, illness, death or property damage arising from or related to the use of the CHP Facilities by me or others including bodily and personal injuries, illness, death, and property damage arising from or related to, directly or indirectly, the negligence of CHP Parties.

I am acquainted with appropriate equestrian safety practices, and it is not the responsibility or obligation of CHP or any CHP Party to teach or advise me of appropriate equestrian safety practices or, to the extent applicable, to enforce any rules or laws related to appropriate equestrian safety practices or the use of protective equipment.

This Assumption of Risk and Release is given on behalf of (a) me and my executors, heirs, and assigns and (b) any child of whom I am a parent or guardian and his or her executors, heirs, and assigns. I agree that, if I am a parent or guardian of a minor participant in equine activities on the CHP Facilities, I consent to the participation by the minor and agree to all of the above provisions and agree to assume all of the obligations of this agreement on behalf of the minor.

If any portion of this Assumption of Risk and Release is held to be invalid by any court or tribunal, the remainder hereof shall continue in full force and effect.

I ACKNOWLEDGE AND AFFIRM—AND, AS APPLICABLE, FURTHER ACKNOWLEDGE AND AFFIRM THE TERMS OF THE ASSUMPTION OF RISK AND RELEASE POSTED AT THE ENTRANCES TO THE PROPERTY—THAT I CAREFULLY READ THE CONTENTS OF THIS ASSUMPTION OF RISK AND RELEASE, FULLY UNDERSTAND ITS MEANING, AND SIGN IT VOLUNTARILY.
